## INSURANCE OF MOUNTAIN RESCUE SERVICE COSTS

The insurer shall pay necessary expenses, with the exception of expenses paid from public health insurance for:

- searching for the person in a mountain area (search)
- rescue of the person,
- land or air transport, if not covered by public health insurance, from the place of Mountain Rescue Service (the "MRS") intervention to the place of transport of the insured person by medical transport service or to the nearest medical facility in the territory of the Slovak Republic
- the transport of the remains from the place of intervention of the mountain rescue service to the place of transport by the transport medical service,

incurred in connection with rescue activities performed by MRS employees (the "MRS intervention") in any of the mountain areas in the territorial competence of the MRS, as listed in the act governing the activity of the Mountain Rescue Service, if such expenses were charged in the territory of the Slovak Republic to the insured person or, in the case of the death of the insured person, to the eligible heir (the "necessary expenses") in accordance with the applicable price list for MRS expenses, issued by the MRS, **up to 20.000 €**.

### Insured persons

Insured are all non-business persons who have exceeded the age of 18 and are eligible for legal acts, regardless nationality, if they have enrolled in an accommodation facility in the area of City of Vysoké Tatry (City of High Tatras). For registration is required to be at least 18 years old and eligible for legal acts. Registration is completed when the enrolled person has been listed in the guest book of accommodation facility in the area of City of Vysoké Tatry (City of High Tatras).

### Risk group

**TOURIST** - the insurance relates to persons who over the duration of the policy perform tourist activities

- a) in pedestrian terrain,
- b) above the upper forest boundary, on marked hiking trails only.

### Exclusions from insurance

- consequences of willful non-compliance with instructions issued by Mountain Rescue Service (including warnings, costs in connection with movement within avalanche threatened terrain, costs in connection with hiking on closed marked hiking trails, etc.),
- other given instructions for persons in the mountain area,
- costs in connection with alcohol, drugs or narcotics.
